<p>Sushila Aggarwal vs State (Nct Of Delhi) on 29 January, 2020</p> <p>Decided by 5 judges Bench</p>	<p>Supreme Court: In a significant ruling, a 5-judge bench of Arun Mishra, Indira Banerjee, Vineet Saran, MR Shah, and Ravindra Bhat, JJ has unanimously ruled that <i>the protection granted to a person under Section 438 Cr.PC should not invariably be limited to a fixed period; it should inure in favour of the accused without any restriction on time.</i></p> <p>While all 5 judges gave a unanimous verdict, MR Shah and Ravindra Bhat, JJ gave elaborate separate opinions.</p>
<p>Secr.,Ministry Of Defence vs Babita Puniya on 17 February, 2020</p>	<p>Supreme Court held that female Naval officers have the right to Permanent Commission (PC).</p>
<p>Indore Development Authority v/s Manohar Lal & Others</p> <p>Decided by 5 judges Bench</p>	<p>The Court clarified the correct interpretation of Section 24(2) of the 2013 Land Acquisition Act. Among other things, it held that land acquisition proceedings cannot lapse merely because the State could not deposit compensation in a landowner's account.</p>
<p>Rambabu Singh Thakur vs Sunil Arora, 2020</p>	<p>Supreme Court: In a major judgment, a bench of RF Nariman and S. Ravindra Bhat, JJ has directed <i>all political parties to upload on their website details of pending criminal cases against candidates contesting polls</i>, noting that there has been an alarming increase in criminalisation of politics.</p>

<p>internet and mobile association of india v RBI SC 2020</p> <p>3 judges bench</p>	<p>RBI ban on Crypto currency set aside</p> <p>In a significant judgement dated 4 March 2020, the Supreme Court of India in Internet and Mobile Association of India v Reserve Bank of India (2020 SCC Online SC 275), struck down a Reserve Bank of India (RBI) Circular that had effectively imposed a ban on virtual currency (VC) trading in India.</p>
<p>Amit Saini Vs Police commissioner SC 2020</p> <p>3 judges bench</p>	<p>Supreme Court, on Wednesday, ruled that "<i>public spaces and public places cannot be occupied indefinitely</i>" and that "<i>dissent and democracy go hand in hand</i>", passing verdict on petitions against the anti-CAA protests in the national capital's Shaheen Bagh.</p> <p>"It is the duty of the administration to remove such blockades of roads, and failure to do so, warranted court's intervention</p>
<p>Central Information Commission Vs. Gujarat High court SC 2020</p> <p>3 judges bench</p>	<p>held that for information to be <i>accessed/certified copies on the judicial side to be obtained, the mechanism provided under the High Court Rules</i> shall be resorted to and not the provisions of the Right to Information Act, 2005 (hereinafter referred to as RTI Act/the Act).</p>
<p>Anuradha Bhasin vs Union Of India SC 2020</p> <p>3 judges bench</p>	<p>Right to internet forms a part of speech and expression under Art.19(1)(a)</p>
<p>Subedar vs The State Of Uttar Pradesh SC 2020</p> <p>3 judges bench</p>	<p>Accused right of being represented through a lawyer is referable to FR to Life.</p>
<p>Pramvir Singh vs Baljeet singh SC 2020</p>	<p>Ensure <i>CCTV cameras are installed</i> in each and every police station.</p>

In its judgment, the court quashed the decision of the private college. The <i>college had refused the renewal of the service contract of an ad-hoc professor who had opted to take maternity leave.</i> Supreme Court upheld the decision of Delhi High Court.
